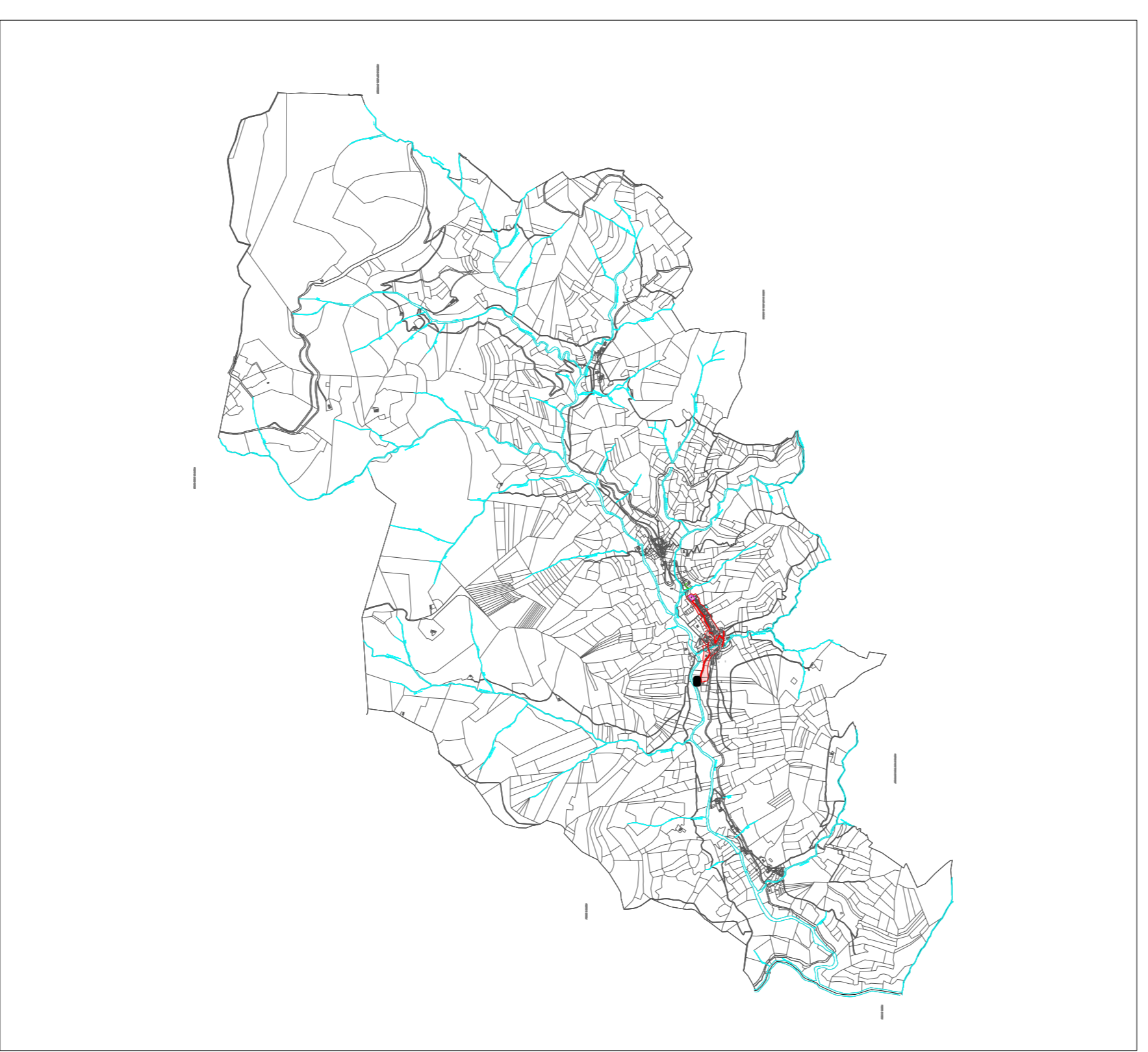


Zone d'assainissement collectif du village
